**THE CHARACTERISTIC OF  
RESPONSES ON DEPRIVATION  
OF REPRESENTATIVE SYSTEMS  
FOR MARRIED COUPLES WITH  
A HUSBENDS' SEX PATHOLOGY**

**Statement of the problem and its relevance.** Concept of sexual health, created and implemented in scientific practice V.Kryshtal involves the study of biological (anatomical and physiological) basis, social, psychological and socio- psychological factors, the totality of which is determined by the rate and sexual function.

Analysis of the biological component makes it possible to assess the presence or absence of anatomical, physiological and biochemical deviations that provide sexual function. The process and content of psychotherapy with sexual disharmony couple at the same time important mechanisms purely psychological processes of communication and response partners We therefore considered as a part of sexual harmony, psychological component. The psychological component of sexual health due to the complex process of interaction between spouses, depending on the conscious and unconscious processes of each pair. Psychological processes of interaction seen through the prism of the author features of personality traits, temperament, personality problems internally,

attitudes (general and sexual), presence (absence) of the negative effects of child.

The main focus in modern sexology is the understanding of sexual disharmony and study the characteristics of sexual disorders and finding treatments based on parity sexual function. More V.Masters and V. Johnson , considering the sexual act as a form of interaction between two individuals argued that all forms of sexual inadequacy in one spouse , usually affecting one's sexual satisfaction more.

The term «complex synthesis «was introduced R.Bendlerom and Dzh.Hrynderom. The authors noted that between the real world and our perceptions of it are some differences. Each patient creates a representation of reality; it is a model that leads to a subjective world view.

The mechanisms that create both successful and unsuccessful attempts of modeling is generalization of phenomena omission and distortion. Generalization - a process in which the elements or parts of the model that belongs to a particular individual, detached from the experience that gave rise to these patterns , and begin to represent a whole category for which this experience is only a particular case of.

In this publication we provide an analysis of one of the manifestations of generalization, disorders of subjective responses in communication husbands and wives who have a complex synthesis.

The complex is a kind of generalization and generalization lies in the fact that the subject determines the

internal state of his companion or sex partner, based on not enough reliable data. For example, on the basis of certain facial expressions, tone of voice and so on. The process is complex generalizations widespread during intercourse spouses who have difficulties in their life together. An important role is played by the representative features of the spouses.

**The purpose of the study.** In our study, we set the goal to study the phenomenon of complex generalizations in the marriage with sexual intercourse during sexual disharmony and disease man based on these features to determine the direction and nature of psychotherapy.

**Materials and methods.** To solve this problem we analyzed the phenomenon of complex generalizations in 48 couples with sexual disharmony due to sexual disease in men. The control group consisted of 48 married couples with sexual dysfunction and sexual disharmony.

The age groups examined were distributed as follows: 21-25 years - 14 men and 23 women, 26-30 years - 11 males, 31-45 years - 12 men, 11 women, 46-50 - 11 men and 14 women.

The survey was conducted by our own method. Patients are being offered special map a comprehensive study, in which one of the blocks made it possible to determine the nature of the investigated phenomenon. Block maps for the study of complex generalizations represents four unfinished sentences, which the patient must finish so that the sentence had ended meaning (content). Here these sentences and instructions.

**Justification of the results.** In analyzing the phenomenon of "complex generalization" we found a number of specific reactions partners. We proposed the following classification of types of response husbands and wives dysharmonichnyh couples:

1. R 1.1. - Attributing a partner's emotional state.

2. R 1.2. - Partner somehow characterized.

3. R 2.1. - The attribution of a certain attitude of one partner to another during the conflict directly.

4. R 2.2. - The attribution of a sustainable relationship one partner to another.

5. R 3.1. - Response relationship in a pair directly in the conflict.

6. R 3.2. - Characterization of stable relationships in the pair.

The first type we took a prescription partner's emotional state, «he is sorry." In the case of the second type of reaction partner are certain characteristics, «he uncultured," "he inattentive," " he was very angry." The next class of reactions - a direct response, focused on his partner: "He is angry at his wife," «his rozdratovuye marriage." The fourth option is to summarize the complex genealogy of a stable partner relationship to partner, «does not respect his wife ", " treat it with contempt to his wife ." Fifth option - definition of relations in the pair at the time of the emergence of a complex generalization: "They quarrel." Finally, the last type of compound synthesis: the attribution of stable relationships in the pair, «they do not love each other."

The couple harmonic pairs in auditory, visual, engine response

detected empathic reactions and neutral - stating reaction. In the couple kinesthetic two healthy emotional reaction: neutral ascertaining the reaction stimulation (significant difference,  $p < 0.001$ ). In rational - neutral and negative responses. As a rational system displays the process of thinking by Category logical models, we explain the reaction of irritation resulting differences perspective. In the context of our research, it can be considered normal. Comparison of the nature of negative emotional response couples with sexual disharmony.

**Conclusions.** These studies make it possible to conclude that for spouses of sexual disharmony because men are sexual diseases characterized by complex generalization to auditory, visual and kinesthetic systems that eliminates adequate assessment of partners of each other. Complex syntheses are characteristic for a patient and his partner. High proved negative reactions of both spouses. Healthy women less as compared to male patients and it are a positive factor that increases the possibility of psychotherapy. From this we can conclude that therapy should be directed primarily at addressing the generalization characteristic of male sexual disorders and their wives. It should take into account the nature of the reactions, namely estimates of expression wives and inclinations of men inadequate due to negative emotional reactions that have focus on the wife.

The nature of complex generalizations therefore, is one of the most important manifestations of

unconscious mechanisms that cause sexual disharmony.
